Lufthansa

Founded in 1926 and approaching its 45th anniversary of serving Philadelphia, Lufthansa proudly sponsors the 20th anniversary of the German-American Chamber of Commerce in Philadelphia.

With 260 weekly flights from its 21 North American gateways, Lufthansa operates the third largest trans-Atlantic route network. Considering Lufthansa's global network of 206 destinations in 78 countries, a Lufthansa jet takes off or lands somewhere in the world roughly every 44 seconds. The airline offers its passengers access to the most comprehensive route network in the world and is the largest European carrier to Asia, Eastern Europe, India, Israel and Italy.

Lufthansa is one of the founding members of Star Alliance, the first global airline alliance. The Star Alliance offers 17,000 daily flights to 916 destinations in 160 countries. Lufthansa's three Star Alliance Partners in North America are United Airlines, Air Canada and US Airways. Continental Airlines is set to join Star Alliance as of October 2009.

In January 2008, Lufthansa acquired a 19 percent stake in New York based carrier JetBlue. This transaction represents the first significant investment by a European air carrier in a U.S. point-to-point air carrier.

Lufthansa has one of the world's youngest, most technologically advanced and environmentally friendly fleets, totaling 545 aircraft with an average age of 11.2 years. The airline has ordered some 188 new aircraft to be delivered between 2009 and 2016.

More than 100,000 employees are currently working for Deutsche Lufthansa AG, representing 146 nationalities.
